

DIVISION 5391 – BEST IN COUNTY QUILTS

Each county may select their best quilt to enter in **Best in County Quilts**. The Best in County needlework item other than quilt is entered in the NSF Textile Arts Department.

- The entry must be one that would qualify to meet the criteria for entries in the 2015 NSF Quilt Department. Note that quilted items like table runners are in the Textile Arts Department and not the Quilt Department at NSF. Refer to Quilt Department Rules, page 4 of this entry book for details.
- The entry must be selected at the local county fair. For joint county fairs, each county may have one entry.
- If the 2015 county fair is held during or after the 2015 NSF, the county winner will be eligible to compete in the Best of County Quilt Division 5391 the following year.
- The exhibitor must be a resident of the county submitting the entry.
- If the first place exhibitor declines, an alternate exhibitor may enter.

Entry Process:

Forms: There are two entry forms that must be completed. These forms are available online or by contacting the NSF office (308-382-1620). However, the entry process itself must be done by mail-in or in person.

Pre-Entry Form: This form requires the signature of the county fair needlework superintendent or another official. Complete this form **immediately following county fair and mail** to Jan Sittler, NSF Quilt Superintendent, 2104 W Charles, Grand Island, NE 68803.

Exhibit's Form: This is completed by the exhibitor and submitted with the exhibit. Attach a label with exhibitor's name, address, telephone number and county to the exhibit. If your delivery and return options are not the same, be sure to note this on the form. Include contact information for the person picking up the exhibit.

Delivery of Exhibit – Deadline is 3 pm Wed, Aug 26 to the Quilt Hall in the Pinnacle Bank Expo Center.

The **Exhibit's Form** must be included with item. Make a note on form if the return method is different.

Exhibit may be delivered by:

- The exhibitor / another person during Quilt entry times Wed, Aug 19, 3 to 8 pm, Thu, Aug 20, 8 am to 3 pm
- Extension staff at the same time they deliver 4-H exhibits (Wed, Aug 26 by 3 pm).
- **Domestic Drop-Off/ Return Sites:** see link for details.
- **Domestic Shipping Options:** see link for details.

Return of Exhibit – No early release

Exhibits may be picked up on Mon, Sep 7, 8-10 pm or Tue, Sep 8, 8 am to noon by exhibitor, another person or extension staff. Be sure to include contact number for person picking up exhibit on the **Exhibitor's Form**.

Also, see **Drop-Off/Return Sites** for return via a drop-off/return site and **Domestic Shipping Options** for returns by shipping.

Note: Exhibits not picked by the above options or with insufficient payment for return shipment must be retrieved from the State Fair Office, 501 E Fonner Park Rd, Ste 200, Grand Island no later than Wed, Oct 7. After that, the items will be donated to charity.
